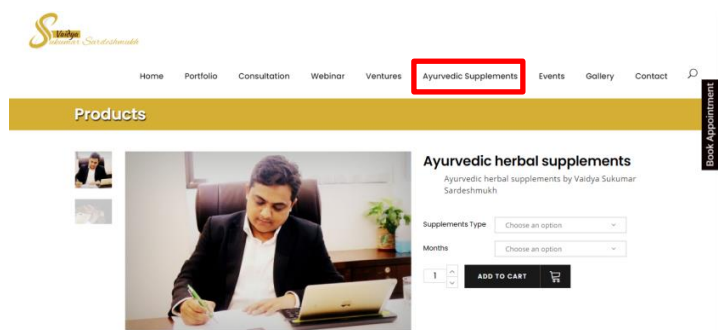


Steps of placing an order on vaidyasukumarsardeshmukh.com website

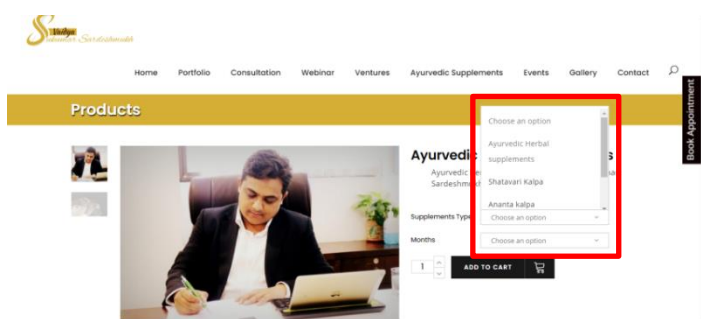
1. Go to vaidyasukumarsardeshmukh.com website / vaidyasukumarsardeshmukh.com に行ってください。



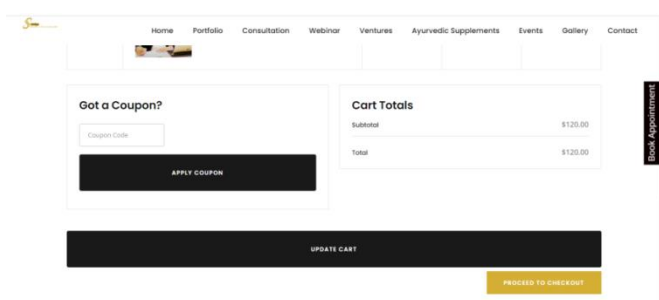
2. Click on Ayurvedic Supplements – Ayurveda supplements (アーユルヴェーダのサプリメント) と書いてあるところをクリック
